Subject : AY 2020-2021 HIGHER EDUCATION DATA COLLECTION AND QUICK SURVEY ON ENROLLMENT, GRADUATES AND HEI PERSONNEL

Date : 9 November 2020

In line with the urgent need to collect higher education data and information to ensure data-driven policy, the Office of the Executive Director through the regional offices, is enjoining all public and private HEIs to comply with the following:

1. Quick Survey on Enrollment, Graduates, and HEI Personnel

The continuing need for updated and timely data during the COVID-19 Pandemic requires the Quick Survey on Enrollment, Graduates, and HEI Personnel which will be conducted using the link: <u>http://bit.lv/CHEDQuickSurvey</u> with deadline <u>on</u> <u>November 15, 2020.</u>

There may be some overlaps between data requested in this quick survey and the data submissions for AY 2020-2021. However, this quick survey ensures faster consolidation and processing of pertinent data on enrollment, graduates, and HEI personnel.

2. AY 2020-2021 Higher Education Data Collection

For AY 2020-2021 data collection, the HEIs are advised to submit their Higher Education Data directly to CHEDRO-III using the existing CHECKS forms with a letter from the HEI President/Head certifying the completeness and correctness of the submitted data.

<u>No need to access the CHECKS portal for this round of data collection</u>. The template of the letter to be signed by the HEI President/Head (Attachment-Annex A) and the data collection guidelines are still based on CHED Memorandum Order No. 45, series of 2016 (Attachment-Annex E) including the forms which can be accessed through the following links:
