**Subject : MATRIX OF CENTRAL LUZON REGIONAL HIGHER EDUCATION ACTION PLAN (CLRHEAP) PRIORITY PROGRAMS**

**Date : 24 November 2020**

Pursuant to 16<sup>th</sup> RDC III Resolution No. 03-44-2020, Regional Development Council (RDC) III initiated a regional investment programming call to update the Central Luzon Regional Development Investment Plan (RDIP) and to formulate a regional annual investment plan (AIP) as input to the FY 2022 budget preparation. The Updated CL RDIP/AIP will contain development investments that are responsive to the target outcomes and outputs of the 2017-2022 Regional Development Plan (RDP) and the various sector/area plans and programs of the government which include among others the **Central Luzon Regional Higher Education Action Plan (CLRHEAP)**.


The CLRHEAP is a product of Region III Higher Education Consortium (R3HEC) comprised of State Universities and Colleges (SUCs), Local Universities and Colleges (LUCs) and Private Higher Education Institutions (PHEIs) in the region focused on five (5) thematic areas: (1) Operations; (2) Instructions; (3) Research; (4) Extension & Productivity; and (5) CHEDRO III Operations. Guided by the principle "Sama-sama at tulong-tulong sa panahon ng pandemya. Walang iwanan sa mataas na antas ng edukasyon sa Rehiyon 3," CLRHEAP aims to guide all the 209 HEIs in Region-III on their moving forward activities aligned with the directives of the National Government and the Commission on the adoption of the new normal. The CLRHEAP was presented to the Sectoral Committee on Social Development (SCSD) on September 24, 2020 and was approved by the Regional Development Council III (RDC-III) through Resolution No. 03-20-2020 at the Full RDC meeting on October 2, 2020.

As requested by the HEIs and agreed during the CLRHEAP cascading activity held on 26 October 2020, all HEIs are furnished with the attached matrix of priority programs as reference for the **CHEDRO-III monitoring activity** on its initial implementation before the year ends.

Further, the SUCs are encouraged to include/integrate the **CLRHEAP priority programs** in their respective investment plans to be submitted to the NEDA III which was discussed in today's workshop on updating the 2022 Annual Investment Plan.
