MITIGATION MEASURES FOR THE SGS-L GRANTEES

The Commission En Banc (CEB), through CEB Resolution No. 713-2020, has approved the following mitigation measures for the Scholarships for Graduate Studies-Local (SGS-L) for the duration of the State of Public Health Emergency and up to two (2) months after, unless earlier revoked by the Commission, to wit:

- 1. Approval to allow the use of e-signatures for certifications, endorsements, and requests of scholars, their sending HEIs and delivering HEIs and duly authorized representatives, subject to validation; provided that the scholars execute an undertaking assuming the veracity of the documents submitted;
- 2. Approval to forego Section C, No. 3, Letter c-ii of CAO No. 02, s. 2019, or the requirement of the Technical Working Group (TWG) Recommendation for the approval of special requests under the jurisdiction of the Commission En Banc; and
- 3. Approved the delegation of the authority to approve cases of Extension and Leave of Absences (LOA) with Extension due to COVID-19, without additional privileges, up to one (1) additional academic year on top of what is stated in Item No. 1A., Section D, Article VI of CHED Memorandum Order (CMO) No. 03, s. 2016, as amended for the duration of the State of Public Health Emergency and up to two (2) months after, unless earlier revoked by the Commission.
