The Commission on Higher Education Regional Office III (CHEDRO-III) launched, in September 2020, the **Region III Higher Education Bayanihan (R3HiEdBayanihan)**, one of the priority projects of the Central Luzon Regional Higher Education Action Plan (CLRHEAP).

For FY 2021, the thrust of the project is to adopt a discipline-based approach to be able to develop online educational resources (OERs) per discipline. The Core Group shall:

- serve as the link between the higher education institutions (HEIs) in the region and the CHEDRO-III, on R3HiEdBayanihan 2021 initiatives;
- spearhead the development and submission of open educational resources (OERs) to the CHEDRO-III. OERs may be any of, but not limited to, the following:
  - Modules;

- Learning packets;
- Instructional materials;
- Educational / Simulated videos;
- Laboratory manuals;
- Learning guides;
- Practice sets; and
- Other teaching and learning resources;
- plan for, organize, implement, evaluate, and submit activity reports pertaining to the R3HiEdBayanihan 2021 activities, under the guidance and supervision of the CHEDRO-III; and
- attend all meetings related to R3HiEdBayanihan 2021.

The designation shall remain in force and in effect until the sign off of the R3HiEdBayanihan OER Development Project. However, the Core Group may still be consulted and/or requested to assist in similar or related undertakings as deemed necessary.
