Subject: MEMBERSHIP TO GOVERNMENT-INDUSTRY-ACADEME-LINKAGES (GIAL)

Date : 21 APRIL 2021

In recognition of the importance of establishing strong government-industry-academe linkages, CHEDRO-III reinforced collaborations with the government agencies, the industry and HEIs on areas of business continuity, student industry exposure and research.

An exploratory meeting had been conducted on 03 February 2021, attended by Department of Agricultural (DA-3), Department of Labor and Employment (DOLE-3), Department of Science and Technology (DOST-3), Department of Trade and Industry (DTI-3) and ten (10) SUCs.
