The CHEDRO III with the Regional Cybernetics Center (RCC) as part of the Central Luzon Higher Education Action Plan (CLRHEAP) and Internationalization of programs, has identified the need for websites as main platform of all Higher Education Institutions (HEIs) in Region III to efficiently and effectively communicate with stakeholders. The presence of websites in all Higher Education Institutions is crucial in strongly making a bold statement in the education sector and let the stakeholders feel the presence of the institution in the cyber world. This will create an atmosphere where client satisfaction is the priority because of the provision of online service to stakeholders responding to the urgent need of clients and will provide proactive service to stakeholders making a ginormous leap in the competitive global arena. The website will also effectively communicate the institution's vision and mission, the qualities, and the offerings to each stakeholders. In effect, the HEIs website presents the totality of the institution's growth and innovations making it more globally competitive.

In the CHEDRO III database, several HEIs do not have their own functional websites yet, particularly eight (8) of the fourteen (14) LUCs in Region III. In order to address the concern, the CHEDRO-III has partnered with the Department of Information and Communications Technology (DICT) Region III in providing the necessary technical trainings to all HEIs in Region III in the development of official websites to be linked with the RCC.

In this connection, the DICT – Luzon Cluster 2 will conduct a Government Web Hosting Service (GWHS) and Domain Name System (DNS) Training on **27-30 September 2021 from 9:00 AM – 4:00 PM via Zoom** (details will be provided later) **for all LUCs**. The following LUCs without websites are highly encouraged to attend:

2. Limay Polytechnic College;

3. Norzagaray College;
4. Polytechnic College of the City of Meycauayan;
5. Baliwag Polytechnic College;
6. Bulacan Polytechnic College;
7. Eduardo L. Joson Memorial College; and
8. Guagua Community College.

All LUCs are requested to have a minimum of three (3) representatives to participate in the said training who possess the following requirements: 1) computer literate; 2) background in web design an advantage; and 3) should have a desktop or laptop.
