The Commission on Higher Education Regional Office III (CHEDRO-III), in partnership with the Department of Tourism Region III invites all concerned to the **Bouncing Forward: Central Luzon Tourism and Hospitality Education Virtual Conference** on **21 October 2021 (Thurs) from 8:00AM to 12:00NN**. With the theme "Forging Ties Among the Government, Industry and Academe Amidst the Pandemic in the Tourism and Hospitality Industry", the event aims to: (1) address issues and concerns in tourism/hospitality education, (2) forge stronger collaborations among CHED, DOT and HEIs, and (3) harmonize the actions of CHED and DOT in addressing concerns related to tourism/hospitality education and industry.

One of the highlights of the said conference will be the Workshop (Breakout Session) where HEIs will discuss from among themselves the following issues and concerns related to tourism/hospitality education:

- Job skill mismatch between graduates of tourism and hospitality education and industry needs;
- 2. Conduct of student industry exposure while face-to-face practicum is still suspended due to the pandemic;
- 3. Recalibration of curriculum to address industry and local needs; and
- 4. Supply of graduates and the demand for BSTM/ BSHM graduates in the next four (4) years
