The Central Luzon Regional Higher Education Action Plan (CLRHEAP) 2020-2022, which was favorably endorsed and adopted by the Central Luzon Regional Development Council (RDC-III) through Resolution No. 03-46-2020 dated 02 October 2021, is a blue print or roadmap to provide higher education institutions (HEIs) directions in mitigating the impact of COVID-19 for the remaining months of 2020 to 2022. This was crafted in collaboration with HEIs in Region III, guided with the mantra, "Sama-sama at Tulong-tulong sa Panahon ng Pandemiya. Walang Iwanan sa Lalong Mataas na Antas ng Edukasyon ng Rehiyon III".

Almost one year after CLRHEAP's implementation, the CHEDRO III monitored the extent of its implementation among the HEIs and at CHEDRO III. The purpose of the monitoring was to track implementation and outputs systematically and measure the effectiveness of the programs and activities identified in the CLRHEAP. The monitoring results shall be used as basis for modification of interventions and assessing the quality of activities being conducted.

In this connection, CHEDRO-III invites all Presidents, Vice Presidents for Academic Affairs, Directors for Research, Directors for Extension and Productivity and other concerned HEI officials in revisiting the CLRHEAP 2020-2022 on 12 November 2021, from 1:00 p.m. to 4:00 p.m. In this activity, the CHEDRO-III will:

- Present the results of the monitoring conducted for the five (5) thematic areas identified in the CLRHEAP: Operations, Instructions, Research, Extension and Productivity, and CHEDRO-III Operations, covering the 1st and 2nd semesters of Academic Year 2020-2021;
- Recognize the active partners and sponsors in the implementation of the priority programs under CLRHEAP;
- 3. Revisit the CLRHEAP; and
- 4. Set off moving forward activities
