AND LOCAL GOVERNMENT UNITS ON THE IMPLEMENTATION OF LIMITED FACE TO FACE CLASSES IN AREAS UNDER ALERT LEVEL 2 AND

SUBMISSION OF VACCINATION DATA

Date: 12 November 2021

The Commission on Higher Education will conduct a Town Hall Meeting with all Higher Education Institutions (HEIs) and Local Government Units (LGUs) on the implementation of Limited Face-to-Face Classes (LF2FC) for Higher Education in areas under Alert Level 2 for CoViD-19 Response, in accordance with the Inter-agency Task Force for the Management of Emerging Infectious Diseases (IATF) Guidelines on the Implementation of Alert Levels System for COVID-19 Response allowing the conduct of limited face-to-face classes for higher education in areas under Alert Level System No. 1, 2 and 3. This is also in support of the announcement of CHED Central Office, in compliance with the IATF direction, that only fully vaccinated students are allowed for the LF2FC. The reason why CHEDO-III, DOH-III, DILG-III and PIA-III will conduct the Regional Simultaneous Vaccination Program for Tertiary Students (RSVP-TS) on 19 November 2021 as an assistance to reach out to all Tertiary Students of Central Luzon to get vaccinated before the end of November 2021.

In this connection, all President / Heads / Officer-In-Charge of HEIs in Region III and officials or representatives from the LGUs in areas under Alert Level 2 are invited to attend a Town Hall Meeting on 16 November 2021 (Tuesday) from 8:00 AM to 10:00 AM via Zoom. Also, HEIs are also requested to accomplish the CHED weekly vaccination report of faculty members, non-teaching personnel and students at https://forms.gle/szyxofbuCFZ2MB719. This is to be accomplished on or before Tuesdays of each week for regular updating of the Regional database on vaccination which will be submitted to CHED Central Office.
