In reference to Sec. 3 of R.A. No. 11396 or An Act Requiring State Universities and Colleges (SUCs) to Prepare and Implement a Land Use Development and Infrastructure Plan (LUDIP) that shall Include the Construction of Dormitories for Students and Housing Sites for Employees", the Commission through Memorandum from the Office of the Chairperson dated 09 December 2021 (copy attached), requires all SUCs to submit their respective LUDIPs to the CHED Office of Institutional Quality Assurance and Governance (OIQAG) by **21 December 2021**.

Don Honorio Ventura Technological State University (DHVSU)	The LUDIP was endorsed to OIQAG on 24 November 2021.	Furnish CHEDRO-III a copy of the letter to DBM RO-III once given the go-signal by OIQAG to submit the LUDIP
Nueva Ecija University of Science and Technology (NEUST)	As advised by the OIQAG per letter dated 21 September 2021, NEUST submitted its Boardapproved LUDIP to DBM RO-III on 22 September 2021. The CHEDRO-III was furnished a copy of the letter to DBM RO-III.	
Pampanga State Agricultural University (PSAU)	There is no submission of LUDIP yet. As verified from PSAU, the LUDIP is its finalization stage. Philippine Merchant Marine Academy (PMMA)	CHEDRO-III reviewed the submitted documents of PMMA and were found to be non-compliant with CMO No. 11, s. 2020. This was communicated during the Board Meeting on 10 December 2021.	Submit corrected/revised LUDIP on or before 15 December 2021 to give CHEDRO-III time to check the conformance of LUDIP to CMO No. 11, s. 2020, before the deadline set by the Office of the Chairperson.
President Ramon Magsaysay State University (PRMSU)	There is no submission of LUDIP yet. As verified from PRMSU, the formulation of LUDIP is still on-going.	Submit the LUDIP on or before 15 December 2021 to give CHEDRO-III time to check the conformance of LUDIP to CMO No. 11, s. 2020, before the deadline set by the Office of the Chairperson.

Tarlac Agricultural University	There is no submission of LUDIP yet. As verified from TAU, enhancement of the LUDIP is still on-going.	Submit the LUDIP on or before 15 December 2021 to give CHEDRO-III time to check the conformance of LUDIP to CMO No. 11, s. 2020, before the deadline set by the Office of the Chairperson.
Tarlac State University	The LUDIP was endorsed to OIQAG on 20 October 2021.	Furnish CHEDRO-III a copy of the letter to DBM RO-III once given the go-signal by OIQAG to submit the LUDIP.

The SUCs' immediate compliance on the aforementioned is sought as R.A.No. 11396 provides that future infrastructure projects of SUCs shall be approved and implemented based on submitted and approved LUDIPs.
