**Subject : CALL FOR SUBMISSION OF APPLICATION FOR THE MEDICAL SCHOLARSHIP AND RETURN SERVICE (MSRS) PROGRAM FOR THE SECOND SEMESTER, ACADEMIC YEAR 2021-2022 AND FIRST SEMESTER, ACADEMIC YEAR 2022-2023**

In accordance with the pertinent provisions of the Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994" and the Implementing Rules and Regulations (IRR) of the Republic Act (RA) No. 11509, otherwise known as the "Doktor Para Sa Bayan" Act, the Commission on Higher Education (CHED), is now accepting applicants for the Medical Scholarship and Return Service (MSRS) program for Doctor of Medicine program for the second semester AY 2021-2022 and first semester, AY 2022-2023.

Interested applicants who wish to apply for the MSRS Program must meet the qualification requirements provided in Section 7 of the IRR:

1. Filipino citizen residing in the Philippines;
2. Graduating student or a graduate of an appropriate undergraduate program identified as a prerequisite for a Doctor of Medicine degree, from ant HEIs duly recognized by CHED, including a direct entrant to the integrated liberal arts and medicine (INTARMED) program who satisfactorily completes the first two (2) years of the program: provided, that deserving incoming second year medical students and those in the higher year levels of Doctor of Medicine program shall also be covered, as long as they have complied with the academic requirements and retention policies of the school in the past terms preceding their scholarship application;
3. Passed the entrance examinations and complied with their requirements for admission into a Doctor of Medicine degree in any of the following SUCs/PHEIs where the scholar intends to enroll or currently enrolled:
