The Commission on Higher Education-Central Luzon Region (CHED-CLR) endorses the conduct of a three-day Seminar-Workshop on Preparing a Community-Based Participatory Action Research Proposal from September 14-16, 2022, to be held via zoom teleconferencing. This activity is jointly organized by the President Ramon Magsaysay State University, Iba, Zambales and Central Luzon State University, Science City of Munoz, Nueva Ecija, in coordination with the Development Council of State Universities and Colleges/Center for Inter-Institutional Research Policies and Studies (DC-SUC III/CIRPS).

The objectives of the said seminar-workshop are anchored on the following:

1. to capacitate faculty-researchers of SUCs and Colleges of Region 3 in the preparation of effective community-based participatory research proposals that reflect the priority agenda of each SUC to cater needs of various clienteles; and

All SUCs and private Colleges of the Region are encouraged to send at least five (5) faculty researchers/representatives involved in the institution's research and development undertakings to this training-writeshop.
