In view of the Commission *en banc* (CEB) approval of the new set of guidelines for the reclassification of faculty positions in state universities and colleges (SUCs), the Commission, through the Office of Institutional Quality Assurance and Governance (OIQAG), shall conduct zonal orientations on the faculty reclassification guidelines and workshops for the development of evaluation templates.

The objectives of the activity are to discuss the new criteria and guidelines to the CHED Regional Offices and the members of the Institutional Evaluation Committees (IECs) of the SUCs; and to review and revise the evaluation templates for the use of the evaluation committees.

Officials from SUCs who are members of the IEC are invited to participate in the said activity. We shall reserve two (2) slots per SUC. All CHEDRO Directors and one (1) Education Supervisor II (ES II) from each CHEDRO involved in the previous NBC 461 evaluations are also invited to participate. In the event that the CHEDRO Director is not available, the CHEDRO Director may send another ES II who had also been involved in the NBC 461 Evaluation Cycles.
