In accordance with Special Provision No. 5 under the Fiscal Year 2023 General Appropriations Act, the Philippine government has authorized the appropriation of PHP 100 million for the issuance of grants to fund innovation programs, activities, and projects in accordance with the Philippine Innovation Act, to be overseen by the National Economic and Development Authority (NEDA).

Towards this, NEDA has established the Electronic Innovation Grants Information System (EIGIS), to simplify the application and submission process for the aforementioned grant, and are requesting that representatives of all interested agencies, attached agencies, operating units, and instrumentalities of the government, including State Universities and Colleges (SUCs) and Local Universities and Colleges (LUCs), to register to EIGIS, beginning 01 March 2023, through the link specified in the attached Memorandum.

Additionally, NEDA is requesting the aid of all parties in the dissemination of the Notice of New User Registration, using the attached graphic poster and recommended caption, to be posted through all available official channels.



Background.

- The government, through Special Provision No. 5 under the Fiscal Year 2023
 General Appropriations Act, has authorized the appropriation of PHP 100
 million for the issuance of grants to fund innovation programs, activities, and
 projects in accordance with the Philippine Innovation Act. The NEDA will
 oversee the administration of these innovation grants.
- 2. To simplify the application and submission procedures for the 2023 Innovation Grants, we will be using the Electronic Innovation Grants Information System (EIGIS). The EIGIS is a web-based information system that shall gather, store, and report data on innovation grant applications. Several modules such as (a) user registration, (b) grant submission, and (c) grant evaluation shall be made accessible on an incremental basis pending the approval of the 2023 Innovation Grants guidelines.
