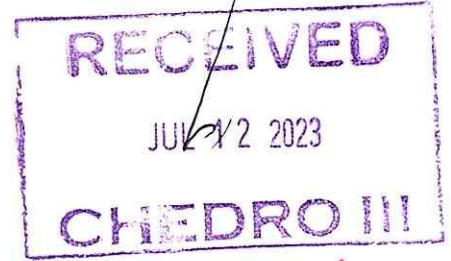

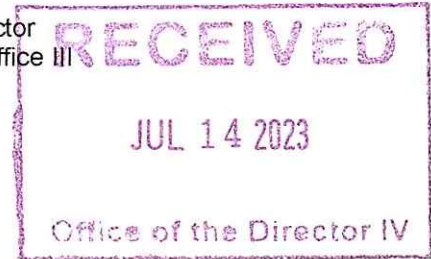


1. Search for the Outstanding Tertiary Campus Journalists (OTCJ)
