Subject : ZONAL REORIENTATION AND FORUM WITH THE HEIS ON CMO 63, S. 2017, OTHERWISE KNOWN AS THE POLICIES AND GUIDELINES FOR LOCAL OFF-CAMPUS ACTIVITIES, RA NO. 11053, OTHERWISE KNOWN AS THE ANTI-HAZING ACT OF 2018 REPUBLIC ACT, AND RA NO. 11313, OTHERWISE KNOWN AS THE SAFE SPACES ACT (BAWAL BASTOS LAW)

In line with the 2023-2028 Philippine Development Plan to "Improve student support to ensure student success" which directs higher education institutions to strengthen their student affairs and services programs in order to provide them a peaceful, safe, secure and healthy learning environment, the Commission on Higher Education (CHED) will hold a two (2)-day Reorientation and Forum with the HEIs on CMO No. 63, s. 2017, otherwise known as the *Policies and Guidelines for Local Off-Campus Activities*, Republic Act No. 11053, otherwise known as the *Anti-Hazing Act of 2018*, and RA No. 11313, and otherwise known as the *Safe Spaces Act (Bawal Bastos Law)*.

Relative to this, the Focal Person or Head of Higher Education Institutions (HEIs) in charge of these programs are invited to attend this activity on November 16-17, 2023 in Baguio City.
