VICTIMS, SURVIVORS, AND THEIR FAMILIES


DATE : 11 JANUARY 2024

This refers to the implementation of Republic Act No. 11468 or the "National Day of Remembrance for Road Crash Victims, Survivors, and their Families Act".

As a shared responsibility, the Commission would like to include in its calendar of activities the commemoration of our brothers and sisters who are victims of road crashes in accordance with Section 4 (g), (h), and (j) of RA No. 11468 to wit: (g) "The flag-raising ceremonies in government offices" (h) "Information dissemination via government agencies and websites" and (j) "Other related programs and activities as may be determined in the implementing rules and regulations", every third Sunday of November each year.

The CHED Central and Regional Offices are directed to implement the above-mentioned provision of laws to show our reverence and oneness with the world on this matter. Also, the CHEDROs are directed to require their respective HEIS to plan activities on the abovementioned matter for implementation of the same in 2024 and the coming years.
