Established through Republic Act 11899, the mandate of EDCOM II is to conduct a comprehensive national evaluation and assessment of the problems faced by the Philippine education system, with the goal of recommending transformative policies and programs to resolve our learning crisis.

Part of its powers and functions under Section 7 of the law is to secure data, reports, and other similar documents from departments, bureaus, offices, or instrumentalities of the government and conduct multi-stakeholder consultations, and formulate policy and program recommendations regarding educational governance and management. In this connection, we would like to request your Higher Education Institution (HEI) and those under you—if your HEI is composed of a main campus and branches—to **respond to the first descriptive questionnaire in the aid of policy making:** <https://tinyurl.com/HEIQuestionnaire>.

We would also like to request that HEI systems with branches consolidate and submit the responses of respective branches. To ensure data integrity, we likewise request the HEI President's confirmation of responses submitted by the HEI(s) under their jurisdiction.

The questionnaire aims to capture profiles of HEIs and collect data on existing quality assurance mechanisms. It covers several sections:

1. Enrollment and graduation figures
2. Programs offered
3. Faculty profile
4. Local and international linkages
5. Internal quality assurance mechanisms
6. Participation in external quality assurances
7. CHED-defined quality assurance

It is highly recommended that the questionnaire be answered by designated staff members with knowledge and access to data pertaining to the aforementioned subjects, provided that they are granted permission to answer it by the HEI President. Should the need arise, the designated staff members will act as the focal persons for further inquiries made by EDCOM II. The same focal person can be appointed for multiple sections within the questionnaire. Please note that there is a section at the end of each section of the questionnaire, requesting for the focal person's contact information.
