
In celebration of the 30th CHED Anniversary and 4th Higher National Education Day and in support and compliance to Executive Order No. 66, s. 2018 otherwise known as the "Institutionalizing of the Philippine Anti-Illegal Drugs Strategy (PADS)", the Commission on Higher Education will hold a contest entitled "2024 Philippine Anti-Illegal Drugs Strategy (PADS) For Higher Education Innovative Awards," (MOED No. 163, s. 2024) which aims to showcase the significant strategies, projects, and innovations being implemented by Higher Education Institutions (HEIs) in the country to comply with the aforementioned Executive Order and to strengthen the anti-illegal drugs program in their respective institutions.

Relative to this, all HEIs in the region are encouraged to join the contest by submitting their entries through a shared Google Drive to be sent via email at chedro3@ched.gov.ph on or before 11:59PM of April 7, 2024. CHEDRO-III shall submit the Top 3 entries to the OSDS on or before 11:59 pm of April 21, 2024.

The Top 3 entries in the region for the **Philippine Anti-Illegal Drugs Strategy (PADS)** will be recognized and awarded during the celebration of the Higher Education Week. Attached is the mechanics and criteria for reference.

2024 PHILIPPINE ANTI-ILLEGAL DRUGS STRATEGY (PADS) INNOVATIVE AWARDS

A. Rationale:

Executive Order No. 66, s. 2018 otherwise known as the "Institutionalizing of the Philippine Anti-Illegal Drugs Strategy (PADS)" directs all government offices, departments, bureaus, agencies and offices, including government owned or controlled corporations (GOCCs) and State Universities and Colleges (SUCs) to implement the said anti-illegal drugs strategy through its projects and programs in accordance with their respective mandates and encourages private and civil society organizations to actively support the same.

In support thereto, the Commission on Higher Education (CHED) will hold a contest entitled, "**2024 Philippine Anti-Illegal Drugs Strategy (PADS) Innovative Awards**" which aims to showcase the significant strategies, projects, and innovations being implemented by Higher Education Institutions (HEIs) in the country to comply with the aforementioned Executive Order and to strengthen their anti-illegal drugs program in their respective institutions.

B. Who May Join:

All interested Private Higher Education Institutions (PHEIs), State Universities and Colleges (SUCs) and Local Universities and Colleges (LUCs) are invited to join the contest.

C. Mechanics of the Contest

1. HEIs must submit a video presentation showcasing their plans, programs, and projects on anti-illegal drugs, highlighting their initiatives that have created impact and/or were found effective to their students, faculty, HEI and/or surrounding communities, as well as their innovations in the implementation of their drug education prevention and control programs.
2. The video presentation must not be less than 3 minutes and must not exceed 5 minutes in length;
3. The Video should be in accordance with the copyright laws. Music, images, etc. used in the entry must be original, licensed or in the public domain. Plagiarism of any kind will result in disqualification.
4. Deadline of submission:
 - a. Deadline of submission of HEI's entry to the CHED Regional Office (CHEDRO) shall be on or before 11:59 pm of April 7, 2024
 - b. Deadline of submission of the Top 3 entries of CHEDROs to the CHED-OSDS shall be on or before 11:59 pm of April 21, 2024

(All Top three (3) regional level entries will compete for the national level category)



5. For the Regional Category, all entries shall be judged on a given criteria by a panel, from the following agencies/organization:
 - a. CHEDRO
 - b. Guidance Counselor/ RQAT-Guidance and Counseling member (should not be connected to the HEI being evaluated)/ Professional Organization on Student Affairs and Services
 - c. Government agencies with programs related to anti-illegal drugs (PDEA/PNP/NAPOLCOM /Local Government Unit/DILG)
6. For the National Category, all entries shall be judged on a given criteria by a panel, from the following agencies/organization from:
 - a. Dangerous Drugs Board
 - b. ASEAN Training Center for Preventive Drug Education (ATCPDE)/NAPOLCOM
 - c. CHED Central Office Director
7. The Top three (3) winners for the regional category shall be recognized by the CHED Regional Office. The winners for the national category shall be awarded in the CHED Central Office.

D. Criteria for Judging

1. Regional Category

2. National Category

- a. Content Clarity and Concept – 35 pts
The video clearly presents the HEIs initiatives, programs and innovation.
- b. Impact – 35 pts
Video and clearly shows the significant impact of the HEIs initiatives, programs and innovation to the students, HEI faculty and administrator, civil society and faith-based organizations, local government.
- c. Creativity – 20 pts
Overall effectiveness of delivery
Video is original, creative and unique hence draws in the viewer and keep their attention



d. Production - 10 pts

Overall quality of production (including visual and sound elements)
Video is well planned, with smooth transitions and edits. Sound is excellently balanced and easy to hear. All elements support the message.

E. Budget

The expenses to be incurred for the contest namely: honorarium, travel and transportation, food and accommodation, supplies for the certificate shall be charged against the OSDS-PADS budget for FY 2024.
