GUIDELINES ON THE UPDATED DIRECTIVE ON THE PROCESSING AND APPROVAL OF TRAVEL CLEARANCE REQUEST FOR 2017-APPROVED SCHOLARS UNDER THE SCHOLARSHIPS FOR GRADUATE STUDIES -

The CHED Regional Office 3 hereby informs all Sending Higher Education Institutions (SHEIs) that the **issuance** of **travel clearance** has been delegated to the respective CHED Regional Directors for **2017-approved** Scholarships for Graduate Studies – Local (SGS-L) scholars within their respective jurisdiction.

Scholars must seek written clearance from the Commission two (2) weeks prior to the date of travel outside the country, inclusive of the period for return service obligation, and submit the following documents in hardcopy format with fresh signatures to the CHED Regional Office 3:

- 1. Official written request with the following information:
 - a. Inclusive dates of travel shall include information on any land, sea or air travel if the scholar will be traveling from one region to another (e.g. if the airport is located in a different region)
 - b. Travel destination/s
 - c. Purpose of the travel
- 2. Certificate of clearance from the DHEI, which must include the following information based on the status of study:
 - a. For scholars who completed the degree Date of graduation and submission of final manuscript with the equivalent academic year and term
 - b. For scholars who are still ongoing with their studies Status of study (e.g. datagathering, for final defense, working on manuscript revisions, etc.) and the academic year and term of expected degree completion
- 3. Certificate of approval from the SHEI
- 4. Copy of travel tickets
- 5. Copy of conference invitations, and other documentation (if applicable); and,
- 6. Notarized affidavit of undertaking for travel clearance (Annex A).

SHEIs are kindly requested to disseminate this information and coordinate with the 2017approved SGS-L scholars from their institutions.

- 8. I am cognizant, willing, and accepting of the commitments that shall follow from my request, in accordance with the policies of the scholarship, including those to be issued in the future.
- I fully understand the consequences of not giving correct and truthful data and I am aware that non-disclosure of material information as required will put me under the pain of perjury by executing this document.
- 10. I fully accept the final decision of the Commission for breach of contract and non-compliance to my contract and affidavit of undertaking, return service agreement, and scholarship policies.
- 11. I authorize the Commission on Higher Education to take possession of any and all assets, money, and/or property under my name to cover any amount I would be found to be owing CHED/government in case I do not return to the Philippines within the period of my permitted travel and I am declared non-compliant with the conditions of my scholarship contract and return service agreement.
